**RE: Infringement of Synergy Law Group® Trademark**

Dear Mr. Silverstein:

I am writing on behalf of Synergy Law Group L.L.C., owner of the trademarks and trade name Synergy Law Group®. Synergy Law Group L.L.C. owns a valid trademark registration covering the Synergy Law Group® marks. Use of such mark by Synergy dates back many years.

You are currently using the name Synergy Law Group® as part of an e-mail address ([REDACTED]@sorehands.com). This use constitutes blatant trademark infringement, unfair competition, dilution, and other causes of action under state and federal law. In addition, your use is likely to cause confusion, and dilutes the distinctive quality of Synergy Law Group L.L.C.'s famous mark, among other wrongs.

Accordingly, we hereby demand that you immediately cease all use of the name "Synergy Law Group®" that in any way infringes Synergy's trademark rights. We also demand that you immediately inform us of any and all uses of any variation of Synergy Law Group, L.L.C.'s marks including, but not limited to, providing all copies of emails you have sent or received using "[REDACTED]@sorehands.com", "[REDACTED]" in conjunction with any other Internet domain, or any other use of the Synergy Law Group® mark.

Should you fail to comply with the demands contained in this letter, appropriate action will be taken against you to enjoin your use of the Synergy Law Group® trademark. This action might include Synergy Law Group, L.L.C. seeking a temporary restraining order, preliminary and permanent injunctive relief, as well as damages for the harm suffered and which continues to be suffered by Synergy Law Group L.L.C., together with attorney fees because of the wrongful deprivation caused by your illegal use of Synergy Law Group, L.L.C.'s registered trademark and trade name. Synergy Law Group, L.L.C. will seek this relief in the appropriate state or federal court in Illinois, which has personal jurisdiction over you in light of the circumstances of your infringement.
